PET OWNER'S GUIDE

OUR PET FRIENDLY POLICY at MEADOW LEE HOLIDAY PARK.

Pets are welcome at Meadow Lee – it is appropriate & understood that by adhering to these simple reasonable rules it will make your holiday, your dogs holiday & everyone else's holiday happy, comfortable, safe & without concern.

Specific Site Conditions of Licence apply to Dog Owners, understandably they are based on the personal safety & well being of all persons using the Park, animal welfare & hygiene combined with Health & Safety precautions.

There is no automatic right for any Caravan Owner to bring a dog onto the Park & should not be assumed as so.

Meadow Lee Holiday Park Limited reserve the right to prevent a dog from being accommodated in a caravan on the Park & to request the dog to be removed from the Park immediately to alternative kennelling as maybe found necessary.

All dogs regardless of their temperament must be kept under control having a collar & short lead on at all times when outside of the caravan. Holding onto a dog is not deemed as suitable or a safe form of restraint.

Meadow Lee Holiday Park Limited reserve the right to assess the behaviour of an Owner's dog & to make judgement as to whether the dogs behaviour is of concern, risk or disturbance to others (being either other dogs or persons.)

Persistent barking dogs cannot be tolerated in the best interest of the Parks atmosphere & in the fairness of other caravan owners.

Dogs must not be left unattended outside of the caravan & if left unattended whilst in the caravan on no account must the dog cause a nuisance or disturbance to anyone else staying on the Park.

Ground hooks are not permitted for tethering dogs as this represents a risk to both the dog & other people passing by. Dogs maybe tethered on a short lead (max 6ft) at the centre of the door side of the van. The tethered Dog should never be left unattended.

Dogs are to be exercised off the Park & under no circumstances be permitted to defecate or urinate or to mark territory anywhere on the Park.

Once on the Beach they can be exercised freely as the Owners see fit & suitable.

Precautions need to be taken when caravan doors are left open to ensure that the dog cannot get out or jump up or out over balcony platform sides at anyone passing by.

In the event your pet accidentally fouls the park grounds, Owners MUST ensure the fouling is picked up, the area properly cleaned immediately & appropriate disposal is dealt with responsibly.

Dogs are never to be left shut in cars parked on the Site.

The welfare of the dog must be borne in mind at all times, especially in variable weather conditions, if a dog is left in a caravan good ventilation must be ensured.

The Laundry & washing machine facilities provided on the Park are not to be used for washing pet bedding or towels used for pet drying or animal hygiene.

Bearing in mind the size & type of accommodation a caravan provides – there is a maximum number of dogs that can be suitably & responsibly accommodated in a caravan. In most circumstances 2 dogs are the expected norm.

The RSPCA would be notified if cases of negligence were suspected & Site Licences would be terminated if circumstances were not promptly resolved.

Meadow Lee Holiday Park Limited would like to extend grateful thanks to all Dog Owners in their endeavours to abide by the appropriate Code of Conduct & take the necessary caring responsibilities required when owning a dog.

We are a Dog Friendly Holiday Park & wish the Dog Owners to act in the best interest of their pet as well as with consideration for all others whom rightfully expect their particular benefits & enjoyment of Meadow Lee Holiday Park.
